CK5 and CK14 are high molecular weight keratins expressed in the cytoplasm of basal cells and myoepithelium of breast tissue. 5 p63 is a transcription factor present in the nuclei of myoepithelial cells. 6 P504S is a peroxisomal and mitochondrial enzyme that plays a role in bile acid synthesis and β -oxidation of branched chain fatty acids. 7

Primary Antibody: Incubate for 30-45 minutes at RT.


